



## **Copyright Policy & Contributor Terms and Conditions – Alive2green**

Editorial contributions are commissioned and/or received by the Publisher, Alive2green, on the following terms and conditions:

1. The Content Manager reserves the right to publish or withhold unsolicited or un-commissioned articles and pictures (submissions), received by the Publisher.
2. The Publisher assumes that the author has granted permission to publish all submissions.
3. The Content Manager's decision to publish or refuse content is final.
4. Submissions will be reviewed and may be rejected, edited or re-written prior to publication. Edits and changes to submissions do not have to be shared with or approved by the author, however the Content Manager will make an effort to involve the writer in any changes.
5. Copyright in respect of un-commissioned or unsolicited submissions remains the property of the author, unless otherwise agreed by the parties. However usage of the submission extends to the publication in which the submission appears and any related print, web or electronic editions.
6. Copyright for all commissioned articles and photography is the property of the Publisher.
7. Commissioned content and photographs may be paid for by the Publisher depending on remuneration terms agreed by the parties in advance of publication, and only where applicable.
8. In the absence of any written agreement to the contrary, all submissions will be deemed to have been submitted without expectation of payment.
9. Contributors are hereby urged to discuss and agree remuneration terms (in writing) with the content manager in advance of commissioning process, where applicable. Any changes to payment rates must be agreed by the Content Manager in writing.
10. All copyright permissions must be sourced by the author for any content, photographs or illustrations submitted (by the author/contributor), if applicable.
11. Overtly promotional submissions will be rejected or edited unless they are specifically required in the brief. Editing costs may be offset against author's fees, if applicable.
12. If submissions are not published, the Content Manager may pay a 'kill-fee' of between 50% and 100% of the commissioned rate, subject to the reasons for rejection.
13. The Content Manager reserves the right to refuse commissioned content or photography if it does not comply with the brief or the requisite quality standards expected by the Publisher. In this instance no 'kill-fee' will be paid to the contributor.
14. Payment for contributions is strictly 30 days from publication of the submitted work by the Publisher.
15. The Publisher reserves the right to publish contributions in whatever edition of the publication that it chooses.
16. Notwithstanding paragraph 15 above, in the event that commissioned articles or photographs are not used within 3 months of submission by the contributor, the fees will become due to the contributor.
17. Contributors warrant that all submissions are their own creations and that all interviews and quotes are correctly represented. Contributors further warrant that all factual statements in their submissions have been properly qualified.
18. Alive2green (the Publisher) has appointed GSA Campbell Consulting to commission and edit editorial contributions for certain publications. GSA Campbell acts on behalf of the Publisher in any agreements undertaken with contributors.
